## WAIVER AND RELEASE

THIS WAIVER AND RELEASE is made by \_\_\_\_\_ (“Exhibitor”) in favor of

### INTENT

As signatory to this waiver and release, Vendor assumes all responsibility for and releases the Conference from all claims as described below arising from the Vendor’s participation in ITP 2012 during the term of this Agreement.

### PREAMBLES

1. The Conference is the sponsor, organizer and manager of an exposition of chemical and scientific equipment commonly referred to as ITP 2012 to be held from September 30 through October 3, 2012 in the Tremont Plaza and Tremont Grand in Baltimore, MD (“the Event”).
2. The Conference has entered into an agreement with Vendor whereby Vendor will sponsor space from the Conference for a table-top at the Event. The term of the Agreement is from September 30 through and including October 3, 2012.
3. All capitalized terms not otherwise defined herein shall have the meaning given those terms in the Agreement.

### CONDITIONS

1. **Waiver and Release:** The Vendor assumes responsibility for and risk of any damage or injury, up to \$1,000,000.00, whether to property or person, including death, that may occur to the Vendor, its employees, agents, licensees, or invitees at or in connection with the Event. The Vendor further releases El Rassi Consulting, ITP 2012 Conference organizers and its officers, directors, employees and agents, and Barr Enterprises from all claims, demands, rights or causes of actions, present or future, known, anticipated or unanticipated, up to \$1,000,000.00, resulting from or arising out of or incident to the Vendor’s use of any facilities at the Tremont Plaza and Tremont Grand in Baltimore, MD or as result of or incident to the Event.
2. **Miscellaneous:** This Waiver and Release is in addition to and not by way of limitation of any term, covenant, condition or indemnification in the Agreement. Vendor understands and acknowledges that Vendor may be waiving important legal rights by its execution of this form and Vendor acknowledges that it has had an opportunity to review this form with counsel of its choice. The person executing this Waiver and Release on behalf of the Vendor hereby confirms that he or she is authorized to do so.
